The traditional source of information in any branch of knowledge are the written words and, therefore, information sources in a given discipline were( and even now) referred to as "literature" that included all definitive sources of information including journals, encyclopedias, handbooks, textbooks, monographs in series, progress reports, annual reviews, conference proceedings, dissertations and databooks. However, with the growth of other forms of dissemination of information specially on electronic media, the term "information sources" was increasingly used in preference to "literature"

Internet information resource can be defined as resources (including documents and non-documents) in electronic format that provide information or an indicator to the information and are accessible over the internet.

There are so many on-line information available Internet with the help of which the user gets his/her relevant information related to his/her fields of specialization. The user may be an individual or group of organizations. With the help of on-line information available on the web, the individual/organization should be more acquainted with latest development taking place in their respected fields.

Journals are publications, which appear periodically. Electronic journals are defined as any journal, magazines, e-zine, newsletter or types of electronic serial publication which is available at the internet and can be accessed using different technologies such as WWW technology, Gopher, Ftp, Telnet, E-mail or listserv. Several traditional journals are now being published both on the web and in print. Current issues or content lists for most of journals are available on the web or distributed to subscribers as e-mail text message.

Internet-based electronic journals started to appear in the beginning of 1990. These journals were mostly delivered as an attachment to e-mail while their back issues were mounted on anonymous ftp sites and users were required to download them from these ftp sites. The libraries and

information centers made them accessible through their gopher sites .

With the advent of www technology in 1993, electronic publishing became more than a novelty. The web as a means of delivery of electronic information has grown steadily since then. As publishers experiment with different publication modes and models. New journals have evolved based on the graphic capabilities of the Internet that are available only in electronic form. Online subscription of journals is becoming very popular now a days.. Many of the libraries are going in for such subscription.. On the Internet many of the journals are freely available. In online subscription we can get access to the issue of journals as well as back volumes.



## HOW TO EVALUATE WEB DOCUMENTS/ JOURNALS

Search engines generate results in millions in which only a few are relevant. In such an environment it is highly recommended that page must be evaluated. Louis Shores has given a checklist for evaluation of web documents. Librarians can use these checkpoints for evaluation of web documents, which they keep in digital library or subject gateway collections. Commonly these points are known as ASTAFS.

1. **Authority:-** The very first step is to identify the author and publisher of the web document . On Internet it is very difficult to find the author and publisher of a website, but one can easily find out the organization , which has hosted the site and is responsible for content generation.
2. **Scope:-** What is the subject covered by the website? Which authors have contributed to the website in case there are many contributors? What is the recent level of the website ? whether the links to other sites are given.; if so whether they are working or not? For example, the Berkeley Sunsite Digital Library, at

California has an exclusive collection of images in different subject areas.

3. **Treatment:-** How accurately is the subject covered? Is the the matter information provided recent?

4. **Arrangement:-** How the information arranged on the website. Besides Arrangement the most common feature is the style of rendering information. The style must be eye catching.

5. **Format :-** What is the format of a document? Here format means basically audio, video, text and image format.

6. **Special Feature:-** If there is any specific feature associated with the document? Specially, has indexing been done? Download given etc.

## **OBJECTIVES OF THE PROJECT**

LIBRES is presently a bi-annual, peer-reviewed electronic journal with an Editorial Board of library and information science scholars.

LIBRES communicates scholarly thought on library and information science.

Since 1990, LIBRES has published non-refereed articles, reports, and drafts as well as news and discussion of library and information science research, applications, and events. The first regular, quarterly issue which includes the peer-reviewed sections was published on Oct. 15, 1993. When warranted by the volume and flow of scholarship, special and/or supplementary issues on emergent themes will be distributed.

LIBRES will be distributed through an ftp site, and a WWW site. Subscribers will be made aware of the available issue by distribution of a quarterly table of contents to LIBRES, LIBREF-L, and other e-conferences that request the service. LIBRES is indexed in ISA, LISA and Singapore Periodicals Index (SPI).

LIBRES encourages authors to take advantage of the multi-media capabilities of the WWW. The native format of LIBRES articles is HTML, and the final articles should be submitted in this format, although other formats such as Adobe PDF, plain text and Word documents will be accepted, and the first version of your contribution should be submitted in Word to assist editorial feedback. The official language of LIBRES is English. Translations into other languages for limited issues may be approved by special arrangement.

Deadlines for the submissions of manuscripts for the reviewed section will be two months before the next issue; i.e., the end of January (for the March issue), and the end of July (for the September issue). All manuscripts will be given at least two blind reviews by a jury of referees.

Authors will be notified within 45 days of submission of acceptance, revisions, or rejection.

Deadlines for the submission of articles for the three non-reviewed sections will be one month before the next issue; the end of February (for the March issue), and the end of August (for the September issue).

Authors will usually be notified within 14 days of submission of acceptance, revisions, or rejection.
